

1 provisions of Chapter 988 of the 1965 Session Laws, as amended, as necessary for the proper
2 discharge of its duties. The chair may appoint committees that are authorized by the Authority's
3 rules and regulations. The Authority shall meet regularly at the times and places specified in its
4 rules and regulations, and special meetings may be called pursuant to those rules. All meetings
5 shall be open to the public. A majority of the members shall constitute a quorum for all purposes.

6 (c) A member of the Authority may only be removed by the appointing authority
7 for inefficiency or neglect of duty or misconduct in office. No member shall be removed unless
8 the member has been given a copy of the charges at least 10 days prior to the hearing and has
9 been given an opportunity to be heard in person or by counsel.

10 **SECTION 1.2.(c) Staff; Employees.** – Within the limits of available funds, the
11 Authority shall appoint the Transylvania Economic Alliance to operate the Authority. The
12 Authority may delegate to one or more of its members, agents, or employees the powers and
13 duties which it deems necessary to carry out its powers and duties, subject always to the
14 supervision and control of the Authority.

15 **SECTION 1.2.(d) Interest of Members or Employees.** – No member or employee of
16 the Authority shall (i) acquire any interest, direct or indirect, in any development project or any
17 property included, or planned to be included, in any development project, or in any area which
18 the member or employee may have reason to believe may be included in any development project
19 or (ii) have any interest, direct or indirect, in any contract or proposed contract for materials or
20 services to be furnished or used by the Authority or in connection with any development project.
21 The acquisition of any interest in a development project or in any property or contract as
22 described in this section shall constitute misconduct in office. If any member or employee of the
23 Authority shall have already owned or controlled within the preceding two years any interest,
24 direct or indirect, in any property later included or planned to be included in any development
25 project under the jurisdiction of the Authority, or has any interest in any contract for material or
26 services to be furnished or used in connection with any development project, the member or
27 employee shall disclose the interest in writing to the Authority, and the disclosure shall be entered
28 upon the minutes of the Authority. Failure to make a disclosure required by this section shall
29 constitute misconduct in office.

30 **SECTION 1.2.(e) Certificate of Incorporation.** – The Authority shall file a copy of
31 this act with the Secretary of State and, upon receipt of the act, the Secretary of State shall issue
32 a certificate of incorporation. In any suit, action, or proceeding involving or relating to the
33 validity or enforcement of any contract or act of the Authority, a copy of the certificate of
34 incorporation duly certified by the Secretary of State shall be admissible in evidence and shall be
35 conclusive proof of the legal establishment of the Authority.

36 **SECTION 1.2.(f) Environmental Issues.** – Notwithstanding any other provision of
37 law, neither Transylvania County or any other county, the State of North Carolina, or any other
38 governmental unit that provides funds to the Authority for a development project or other project
39 shall be liable for any environmental issues, known or unknown, related to the project solely
40 because of providing funds.

41 **SECTION 1.2.(g)** This section applies only to Transylvania County.
42

43 **PART II. VARIOUS MUNICIPAL MODIFICATIONS**

44 **TOWN OF BOILING SPRINGS CHARTER**

45 **SECTION 2.1.(a)** The Charter of the Town of Boiling Springs is revised and
46 consolidated to read:
47

48 "THE CHARTER OF THE TOWN OF BOILING SPRINGS.

49 "ARTICLE I. INCORPORATION AND CORPORATE POWERS.

1 "Section 1.1. Incorporation. The Town of Boiling Springs, in Cleveland County, North
2 Carolina, and the inhabitants thereof, shall continue to be a municipal body politic and corporate,
3 under the name of the "Town of Boiling Springs," hereinafter referred to as the "Town."

4 "Section 1.2. Powers. The Town shall continue to be vested with all of the property and
5 rights in property belonging to the Town; shall have perpetual succession; may sue and be sued;
6 may contract and be contracted with; may acquire and hold any property, real and personal,
7 devised, bequeathed, sold, or in any manner conveyed, dedicated to, or otherwise acquired by it;
8 and, from time to time, may hold, invest, sell, or dispose of the same, may have a common seal,
9 and alter and renew the same at will. The enumeration of any particular powers, rights,
10 immunities, or authorities shall not be held or deemed to be exclusive. In addition to any powers,
11 rights, or authorities enumerated or implied under this Charter, the Town shall have and may
12 exercise all the powers, functions, duties, rights, privileges, and immunities of every kind and
13 nature whatsoever conferred upon the Town now or in the future under the general laws of the
14 State of North Carolina, local acts applicable to the Town, and this Charter.

15 "ARTICLE II. CORPORATE BOUNDARIES.

16 "Section 2.1. Corporate Boundaries. The corporate limits of the Town shall be those existing
17 at the time of ratification of this Charter, as the same are set forth on an official map of the Town,
18 and as such limits may be altered from time to time in accordance with law. An official map of
19 the Town, showing the current municipal boundaries, shall be maintained permanently in the
20 office of the Town Clerk and shall be available for public inspection. Upon alteration of the limits
21 pursuant to law, the appropriate changes to the official map of the Town shall be made and copies
22 shall be filed in the office of the Secretary of State, the Cleveland County Register of Deeds, and
23 the Cleveland County Board of Elections.

24 "ARTICLE III. GOVERNING BODY.

25 "Section 3.1. Governing Body. The Town Council (hereinafter "Council") and the Mayor
26 shall be the governing body of the Town. When the context of this Charter requires it, "the Town"
27 shall mean the governing body of the Town.

28 "Section 3.2. Composition of Town Council. The Council shall consist of five members,
29 each to be elected at large by the qualified voters of the Town in the manner provided in Article
30 IV of this Charter.

31 "Section 3.3. Mayor. The Mayor shall be elected by the qualified voters of the Town voting
32 at large in the manner provided in Article IV of this Charter. The Mayor shall be the official head
33 of the Town government and shall preside at all meetings of the Council. The Mayor shall vote
34 only in the case of a tie.

35 "Section 3.4. Mayor Pro Tempore. In accordance with general law, the Council shall elect
36 one of its members to act as Mayor Pro Tempore to perform the duties of the Mayor during the
37 Mayor's absence.

38 "Section 3.5. Terms and Vacancies. Members of the Council shall serve staggered four-year
39 terms with three members elected in the same election every four years and two members and
40 the Mayor elected in the same election two years thereafter. The Mayor shall serve a four-year
41 term. Vacancies that occur in any elective office of the Town shall be filled in accordance with
42 G.S. 160A-63.

43 "Section 3.6. Meetings. In accordance with general law, the Council shall establish a suitable
44 time and place for its regular meetings. Special and emergency meetings may be held as provided
45 by general law. Official actions of the Council and all votes shall be taken in accordance with the
46 applicable provisions of general law.

47 "ARTICLE IV. ELECTIONS.

48 "Section 4.1. Regular Municipal Elections. Regular municipal elections shall be held in each
49 odd-numbered year in accordance with the uniform municipal election laws of North Carolina.
50 The election of members of the Council and the Mayor shall be conducted on a nonpartisan basis,
51 and the results determined using the nonpartisan plurality method as provided by G.S. 163-292.

1 "ARTICLE V. ORGANIZATION AND ADMINISTRATION.

2 "Section 5.1. Form of Government. The Town shall operate under the council-manager form
3 of government in accordance with Part 2 of Article 7 of Chapter 160A of the General Statutes.

4 "Section 5.2. Town Manager. The Council shall appoint a Town Manager to serve at its
5 pleasure who shall be the chief administrative official of Town government, and who shall be
6 responsible to the Council for the proper administration of the affairs of the Town. The Town
7 Manager shall have those powers and duties provided by general law. In addition, the Town
8 Manager shall appoint the Town Clerk, Finance Officer, Tax Collector, and Chief of Police and
9 may create new positions or departments or assign additional functions to offices, positions, or
10 departments as provided by general law.

11 "Section 5.3. Town Attorney. The Council shall appoint a Town Attorney who shall represent
12 the Town, advise Town officials, and perform other duties required by law or as the Council may
13 direct."

14 **SECTION 2.1.(b)** The purpose of this section is to revise the Charter of the Town
15 of Boiling Springs and to consolidate certain acts concerning the property, affairs, and
16 government of the Town. It is intended to continue without interruption those provisions of prior
17 acts that are expressly consolidated into this section and those provisions of prior acts which are
18 not inconsistent with the foregoing so that all rights and liabilities which have accrued are
19 preserved and may be enforced.

20 **SECTION 2.1.(c)** This section does not repeal or affect any acts concerning the
21 property, affairs, or government of public schools or any acts validating official actions,
22 proceedings, contracts, or obligations of any kind.

23 **SECTION 2.1.(d)** The following acts, having served the purposes for which they
24 were enacted or having been consolidated into this section, are expressly repealed:

- 25 (1) Chapter 279 of the Private Laws of 1911.
- 26 (2) Chapter 273 of the Private Laws of 1913.
- 27 (3) Chapter 1188 of the 1951 Session Laws.
- 28 (4) Chapter 668 of the 1957 Session Laws.

29 **SECTION 2.1.(e)** This section does not affect any rights or interests that arose under
30 any provisions repealed by this section.

31 **SECTION 2.1.(f)** All existing ordinances, resolutions, and other provisions of the
32 Town of Boiling Springs not inconsistent with the provisions of this section shall continue in
33 effect until repealed or amended.

34 **SECTION 2.1.(g)** Whenever a reference is made in this section to a particular
35 provision of the General Statutes and such provision is later amended, superseded, or recodified,
36 the reference shall be deemed amended to refer to the amended General Statute or to the General
37 Statute that most clearly corresponds to the statutory provision that is superseded or recodified.

38 **SECTION 2.1.(h)** If any provision of this section or application thereof is held
39 invalid, such invalidity shall not affect other provisions or applications of this section that can be
40 given effect without the invalid provision or application and, to this end, the provisions of this
41 section are declared to be severable.

42
43 **MILLS RIVER UNIFIED DEVELOPMENT ORDINANCE**

44 **SECTION 2.3.(a)** Notwithstanding G.S. 160D-601, as amended by Section 3K.1(a)
45 of S.L. 2024-57, the Town of Mills River may adopt the unified development ordinance initiated
46 by the Town Council in October 2024.

47 **SECTION 2.3.(b)** This section is effective when it becomes law, and any adoption
48 of the unified development ordinance shall occur on or before July 1, 2026.

49
50 **TOWN OF MOORESVILLE PROPERTY CONVEYANCES**

1 **SECTION 2.4.** The Charter of Mooresville, being Chapter 239 of the 1975 Session
2 Laws, is amended by adding a new section to read:

3 "Sec. 11.4. Conveyance of property. (a) Notwithstanding any other provision of law, the
4 Board of Commissioners may, with or without consideration, and upon such terms as it deems
5 wise, convey real property owned by the Town for one or more of the following purposes: (i)
6 affordable housing for low- and moderate-income persons, (ii) housing for veterans, and (iii)
7 housing for emergency responders; provided, however, no real property acquired by the exercise
8 of eminent domain may be conveyed under this section. The deed conveying the real property
9 may contain a restriction which provides that the real property shall revert to the Town if it ceases
10 to be used for increasing the supply of housing, as authorized in this section, prior to the
11 expiration of the time period established by the Board of Commissioners. Any conveyance of
12 real property under this section may be made only pursuant to a resolution adopted by the Board
13 of Commissioners at a regular or special meeting authorizing a municipal official designated by
14 the Board of Commissioners in accordance with this Charter or general or local law to make the
15 conveyance for one or more of the purposes authorized in this section. The resolution shall be
16 posted on the Town's website at least 10 calendar days prior to the date the conveyance is
17 executed by the municipal official.

18 (b) For purposes of this section, the following definitions shall apply:

19 (1) Emergency responder. – A firefighter, law enforcement officer, paramedic,
20 emergency medical technician, or other individual, including an employee of
21 a legally organized and recognized volunteer organization, whether
22 compensated or not, who, in the course of his or her professional duties,
23 responds to fire, medical, hazardous material, or other similar emergencies.

24 (2) Veteran. – A person who served as a member of the United States Armed
25 Forces in active duty, as defined by 38 U.S.C. § 101, and who was either
26 separated from the United States Armed Forces under honorable conditions or
27 who is currently serving in a second or subsequent enlistment. The term also
28 means a person who was separated from the United States Armed Forces
29 under honorable conditions with a disability that was incurred (i) as a direct
30 result of armed conflict or (ii) while the person was engaged in
31 extra-hazardous service, including service under conditions simulating war."

32 33 **CITY OF WILMINGTON PROPERTY CONVEYANCES**

34 **SECTION 2.5.** Section 13.8 of the Charter of the City of Wilmington, as amended
35 by Chapter 615 of the 1991 Session Laws, reads as rewritten:

36 "Sec. 13.8. **Conditions and Restrictions on the Sale of Property.** (a) The City of
37 Wilmington may make any sale, exchange, or transfer of property pursuant to G.S. 160A-268,
38 160A-269, 160A-270, or 160A-271 in any manner authorized by general or local law, subject to
39 such covenants, conditions, and restrictions as the City Council may deem to be in the public
40 interest.

41 (b) Conveyance of real property with restrictions. The City Council may, in addition to
42 other authorized means, approve the sale, exchange, or transfer of the fee or any lesser interest
43 in real property, either by public sale or by negotiated private sale. The transfer shall be in
44 furtherance of adopted City policies or plans for the area. The City may attach to the transfer and
45 to the interest conveyed any covenants, conditions, or restrictions, or a combination of them, the
46 City deems necessary to further the adopted policies or plans. The consideration received by the
47 City for the conveyance may reflect the restricted use of the property resulting from the
48 covenants, conditions, or restrictions. The City may invite bids or written proposals, including
49 detailed development plans and site plans, for the purchase of any such property or property
50 interest, whether by sale, exchange, or other transfer, pursuant to the specifications as may be
51 approved by the City. A sale, exchange, or other transfer of real property, or interest therein,

1 pursuant to this section may be made contingent upon any necessary rezoning of the property.
2 Any conveyance under this section may be made only pursuant to a resolution of the City Council
3 authorizing the conveyance. Notice by publication of the proposed transaction shall be given at
4 least 10 days prior to adoption of the resolution, and the notice shall generally describe (i) the
5 property involved, (ii) the nature of the interest to be conveyed, and (iii) all of the material terms
6 of the proposed transaction, including any covenants, conditions, or restrictions which may be
7 applicable. The notice shall give the time and place of the City Council meeting where the
8 proposed transaction will be considered and shall announce the Council's intention to authorize
9 the proposed transaction. The authority contained in this section is in addition to, and not in
10 limitation of, any other authority granted by this Charter or any other general or local law."

11 **PART III. VARIOUS COUNTY MODIFICATIONS**

12 **TEMPORARILY MODIFY DISTRIBUTION AND USE OF LOCAL SALES AND USE** 13 **TAX ALLOCATED TO BUNCOMBE COUNTY AND MAKE TECHNICAL CHANGES** 14 **TO BUNCOMBE SCHOOL CAPITAL FUND COMMISSION**

15 **SECTION 3.1.(a)** Notwithstanding Section 6 of Chapter 134 of the 1983 Session
16 Laws, as amended by Chapter 534 of the 1983 Session Laws and S.L. 2016-19, directing that
17 one-half of the local government sales and use tax revenue be distributed to the School Capital
18 Fund Commission for Buncombe County (Commission), the Secretary of Revenue shall
19 distribute one hundred percent (100%) of the net proceeds of the local government sales and use
20 tax revenue collected by Buncombe County under Article 39 of Chapter 105 of the General
21 Statutes in accordance with G.S. 105-472 using the ad valorem method of distribution.
22 Notwithstanding the provision in G.S. 105-472 allowing counties to change the method of
23 distribution, Buncombe County is not permitted to change the method of distribution for any year
24 for which the distribution and use provisions of this section apply.

25 **SECTION 3.1.(b)** Notwithstanding the use provisions in Sections 9 through 12 of
26 Chapter 134 of the 1983 Session Laws, as amended by Chapter 534 of the 1983 Session Laws
27 and S.L. 2016-19, and applicable to the funds distributed to the Commission, Buncombe County
28 shall use the net proceeds of the local government sales and use tax revenue collected under
29 Article 39 of Chapter 105 of the General Statutes and allocated to Buncombe County under
30 subsection (a) of this section as follows:

- 31 (1) Fifty percent (50%) for local school administrative unit capital outlay
32 purposes, as defined in G.S. 115C-426(f), or to retire any indebtedness
33 incurred by the County for these purposes, and for local school administrative
34 unit operating expenses. Prior to any funds allocated under this subdivision
35 being used for local school administrative unit operating expenses, the
36 Buncombe County Board of Commissioners must provide the Buncombe
37 County Board of Education and the Asheville City Board of Education the
38 opportunity to present at a public meeting the impacts of not using those funds
39 on school capital projects. The Commission shall serve in an advisory capacity
40 to the Buncombe County Board of County Commissioners with respect to the
41 use of funds under this subdivision for school capital outlay purposes by
42 considering the capital needs of both the Buncombe County School System
43 and the Asheville City School System, prioritizing those needs, and
44 recommending projects to be funded. However, the use of funds under this
45 subdivision shall not be under the control of the Commission and shall be
46 determined by the Board of Commissioners.

- 47 (2) Fifty percent (50%) for any public purpose.

48 **SECTION 3.1.(c)** To the extent Buncombe County receives any federal or State
49 disaster funding as revenue replacement, the county shall return a proportionate share of revenue
50
51

1 replacement funds to the Commission up to the amount of diverted funds under this section. The
2 proportionate share shall be equal to the amount of revenue replacement received divided by the
3 County's total revenue loss multiplied by the amount of diverted funds. Any remaining funds
4 shall be used for any purposes allowed by the granting entity. For purposes of this subsection,
5 the following definitions apply:

- 6 (1) Revenue replacement. – Grant monies to compensate for tax or fee revenue
7 lost as the result of the impacts of Hurricane Helene to the extent the monies
8 are unrestricted in use and available for any public purpose.
- 9 (2) Total revenue loss. – Tax and fee revenue projected in the county budget for
10 FY 2024-2025 that was not realized due to the impacts of Hurricane Helene.
- 11 (3) Diverted funds. – The total amount of funds distributed by the Secretary of
12 Revenue to Buncombe County under subsection (a) of this section and used
13 for local school administrative unit operating expenses in accordance with
14 subdivision (1) of subsection (b) of this section.

15 **SECTION 3.1.(d)** This section is effective when it becomes law and applies to net
16 proceeds distributed to Buncombe County by the Secretary of Revenue under Article 39 of
17 Chapter 105 of the General Statutes on or after July 1, 2025, and expires on June 30, 2027.

18 **SECTION 3.2.(a)** Chapter 134 of the 1983 Session Laws, as amended by Chapter
19 534 of the 1983 Session Laws and S.L. 2016-19, is rewritten and recodified as subsections (b)
20 through (m) of this section.

21 **SECTION 3.2.(b)** There is hereby created a Commission to be known as the School
22 Capital Fund Commission for Buncombe County, which Commission shall have and possess all
23 the powers conferred by this section and such other powers as may be useful or necessary to
24 permit it fully to carry out the purposes of this section. The Commission is hereby declared to be
25 a corporation with perpetual succession, the right to adopt and use a corporate seal, to sue and to
26 be sued, and to hold, manage, and control the moneys and properties received by it under the
27 provisions of this section. It shall have the right to make reasonable rules and regulations for the
28 conduct of its business.

29 **SECTION 3.2.(c)** The Commission shall consist of five members. Members of the
30 Commission shall serve two-year terms and shall be appointed as follows: one appointed by the
31 Asheville City Board of Education, one appointed by the Buncombe County Board of Education,
32 two appointed by the Buncombe County Board of Commissioners, and one appointed by the
33 other four appointees. A member appointed by a local governing board or a school board shall
34 serve at the pleasure of that board. The member appointed by the other appointees shall serve at
35 the pleasure of the majority of the other appointees. Any vacancy shall be filled by the appointing
36 authority of the member creating the vacancy to fill the unexpired term.

37 **SECTION 3.2.(d)** A quorum shall be three members of the Commission.

38 **SECTION 3.2.(e)** The Commission shall organize, adopt bylaws or rules and
39 regulations to govern its procedure and the conduct of the business and affairs of the Commission,
40 and appoint a chairman and vice-chairman from among its membership who shall serve a
41 one-year term and appoint a secretary for a one-year term and until their successors are appointed
42 by the Commission. The finance officer for Buncombe County shall be the finance officer of the
43 Commission. The county finance officer shall give bond for the faithful performance of his duties
44 as the finance officer of the Commission in an amount determined by the Commission. The
45 finance officer of the Commission shall manage the funds of the Commission only as directed
46 by the Commission. The Commission may select and appoint an attorney of the Commission to
47 serve at the pleasure of the Commission. The Commission may fix the compensation for the
48 attorney.

49 **SECTION 3.2.(f)** Regular or stated meetings of the Commission shall be held at
50 such time and place as may be provided by the Commission in its bylaws or rules and regulations,
51 and special meetings may be held on the call of the chairman after due notice.

1 **SECTION 3.2.(g)** One-half of any local government sales and use tax revenue
2 distributed to Buncombe County under G.S. 105-472 shall be paid to the Commission by the
3 Secretary of Revenue; provided that if distribution of the local government sales and use tax
4 revenue is made under G.S. 105-472(2), (the ad valorem method), then taxing districts shall
5 receive their funds under G.S. 105-472(2) as if no funds had been paid to the Commission by the
6 Secretary of Revenue, and in computing what amount is one-half of the sales and use tax revenue,
7 the Secretary of Revenue shall not reduce the total by the amount to be distributed to the taxing
8 districts. This section does not affect the distribution of any local or State sales and use tax
9 revenue to the municipalities in Buncombe County.

10 **SECTION 3.2.(h)** Any other capital funds appropriated by Buncombe County
11 pursuant to Article 40 and Article 42 of Chapter 105 of the General Statutes shall be apportioned
12 among the Asheville City Board of Education and the Buncombe County Board of Education
13 according to the membership of each unit using the process set forth in G.S. 115C-430.
14 Buncombe County shall maintain separate internal accounts for each school board in order to
15 comply with this section. These funds are not under the control of the School Capital Fund
16 Commission.

17 **SECTION 3.2.(i)** All funds received by the Commission under subsection (g) of this
18 section shall be placed in a capital reserve fund as provided in Part 2 of Article 3 of Chapter 159
19 of the General Statutes. The capital reserve fund shall be known as the Public School Capital
20 Needs Fund.

21 **SECTION 3.2.(j)** All funds in the Public School Capital Needs Fund shall be used
22 to finance new public school construction, to finance public school improvement and renovation
23 projects that exceed one hundred thousand dollars (\$100,000), or to retire any indebtedness
24 incurred by the county for these purposes.

25 The Commission shall consider the capital needs of both the Buncombe County
26 School System and the Asheville City School System, prioritize those needs, and recommend
27 projects to be funded from the Public School Capital Needs Fund to the board of county
28 commissioners based on the priority of needs determined.

29 By joint agreement of the board of county commissioners and both boards of
30 education, money may be transferred from the account under this section of one board of
31 education to the account under this section of the other board of education, provided that the
32 agreement must require a transfer back of an equal amount of funds at some fixed date in the
33 future, plus a sum to be determined at that date which represents interest which would have
34 accrued on the funds if they had remained in the first account.

35 **SECTION 3.2.(k)** Moneys in the Public School Capital Needs Fund shall be subject
36 to appropriation by the board of county commissioners. The Commission shall disburse such
37 moneys as a ministerial duty upon receiving a written request from the board of county
38 commissioners after the county board of commissioners has adopted an ordinance and after
39 receipt of a written request from the appropriate board of education indicating it is prepared to
40 enter into a contract, and G.S. 115C-521 shall continue to apply.

41 **SECTION 3.2.(l)** Notwithstanding any other provision of this section, if the
42 Buncombe County Board of Commissioners appropriates any federal revenue sharing funds to
43 the Commission for the purpose of substituting revenue sharing funds for sales tax funds, then it
44 must at the same time appropriate from the Commission to the county an equal amount of funds
45 received under subsection (g) of this section to be used for such purposes as the Board of
46 Commissioners shall deem appropriate and are otherwise authorized by law, provided that such
47 federal revenue sharing funds shall be divided pro rata under subsection (j) of this section.

48 **SECTION 3.2.(m)** The reasonable and necessary expenses of the Commission,
49 including the compensation of its officers and employees and the cost of any bond required by
50 it, shall be paid by the County of Buncombe. The chairman of the Commission shall, on or about
51 the first day of each calendar month, certify to the governing body of Buncombe County the

1 expenses of the Commission incurred during the preceding month, and the governing body of the
2 county shall forthwith, and within five days thereafter, cause to be paid to the Commission the
3 expenses required to be paid. All such payments shall be charged to the general fund of the
4 county.

5 6 **ALLOW MITCHELL AND YANCEY COUNTIES TO SIGN MEMORANDUMS OF** 7 **UNDERSTANDING WITH UNICOI COUNTY**

8 **SECTION 3.3.(a)** Notwithstanding any provision of law to the contrary, the Mitchell
9 County Sheriff's Office and the Yancey County Sheriff's Office may enter into memorandums of
10 understanding with the Unicoi County, Tennessee, Sheriff's Office to engage across state lines in
11 law enforcement special operations missions and cooperative law enforcement actions.

12 **SECTION 3.3.(b)** Any memorandum of understanding entered into pursuant to this
13 section shall specify the manner in which liability claims for damage to persons or property as a
14 result of law enforcement special operations missions and cooperative law enforcement actions
15 will be shared or assigned. While ensuring public safety, each memorandum of understanding
16 shall limit to the greatest extent possible the liability of Mitchell County, Yancey County, and
17 the State.

18 **SECTION 3.3.(c)** No later than November 1 of each year, any memorandum of
19 understanding entered into that year pursuant to this section shall be reported to the Department
20 of Justice.

23 **SECTION 3.5.(a)** G.S. 160D-602 reads as rewritten:

27 the authority to conduct the hearing required under this Article and make the final decision on
28 zoning map amendment proposals, including the adoption of a consistency statement pursuant to
29 this Article. The governing board may prescribe procedures for the hearing that are not
30 inconsistent with this Article. The planning board shall make its final decision by majority vote
31 of the members of the planning board. Any person with standing may appeal a decision of the
32 planning board made pursuant to this subsection to the governing board by providing written
33 notice to the clerk to the governing board within 15 days of the final decision. On appeal, the
34 governing board shall review the decision of the planning board de novo. If no notice of appeal
35 of the planning board decision is provided within 15 days of the final decision, then the decision
36 of the planning board shall be final and equivalent to the final decision of the governing board.
37 The governing board may, by ordinance, rescind or modify any authority delegated to the
38 planning board pursuant to this subsection."

42 43 **COLUMBUS COUNTY BOARD OF EDUCATION**

45 Education shall consist of five members elected to serve staggered four-year terms. Five members
46 shall be elected from residency districts. One member shall be elected from each residency
47 district by the qualified voters of the entire county, excluding the area encompassing the
48 Whiteville City School Administrative Unit. No person shall be eligible to file for or be elected
49 to the Columbus County Board of Education unless the person is a qualified voter and resident
50 of the residency district in which the person seeks to be elected.

1 **SECTION 4.1.(b)** Notwithstanding G.S. 115C-37, members of the Columbus
2 County Board of Education shall be elected on a partisan basis at the time of the general election
3 in each even-numbered year as terms expire. Candidates for election to the Columbus County
4 Board of Education shall be nominated at the same time and in the same manner as other county
5 officers. Members shall take office on the first Monday in December following their election.
6 Members shall serve until their successors are elected and qualified.

7 **SECTION 4.1.(c)** All vacancies in the membership of the Columbus County Board
8 of Education by death, resignation, or other causes shall be filled in accordance with
9 G.S. 115C-37.1.

10 **SECTION 4.1.(d)** This section does not affect the terms of office of any person
11 elected in 2024 to the Columbus County Board of Education. Any vacancy on the Columbus
12 County Board of Education for a member elected in 2024 shall be filled by appointment by the
13 remaining members of the Columbus County Board of Education to serve the remainder of the
14 unexpired term. Each member of the Columbus County Board of Education elected in 2024, or
15 any member appointed to fill a vacancy for a member elected in 2024, shall serve until a successor
16 has been elected and qualified.

44 Board of Education for a member elected in 2024 shall be filled by appointment by the remaining
45 members of the Scotland County Board of Education to serve the remainder of the unexpired
46 term. Each member of the Scotland County Board of Education elected in 2024, or any member
47 appointed to fill a vacancy for a member elected in 2024, shall serve until a successor has been
48 elected and qualified.

49 **JOHNSTON COUNTY BOARD OF EDUCATION**
